Void Where Prohibited By Law

1. SPONSOR AND OVERVIEW: The *Capital One Insider* Sweepstakes starts on June 1, 2017 at 12:00 AM Pacific Time and closes on May 31, 2018 at 11:59 PM Pacific Time (the "Sweepstakes Period") However, the Promotion consists of Twelve (12) separate sweepstakes each with it's own Entry Period (each an "Entry Period"), and will be contained within one month, starting at 12:00 a.m. PST on the 1st day of the month and end by 11:59 p.m. PST on the last day of the month.

The Sweepstakes is sponsored by Capital One Bank (USA), N.A., and Capital One, N.A. - (the "Sponsor") and administered by Vision Critical (US) Inc. ("VCI").

2. ELIGIBILITY: This Sweepstakes is open to all registered members of *Capital One Insider Community*, other individuals directly contacted by VCI and invited to participate in the *Capital One Insider Community* Study and individuals who enter in accordance with Section 5 of these Official Rules ("Entrants"). All Entrants must be eighteen (18) or older at the time of the entry and legally reside in the United States or the District of Columbia and at the time of entry into the Sweepstakes. 7. SWEEPSTAKES DRAW(S): The drawing for each Entry Period will be held in Vancouver, British Columbia on each of the Draw Dates from all eligible entries received. Entries from one Entry Period will not carry over to any other Entry Period. Potential winners will be determined by random drawing from all eligible entries received by VCI.
